RULES & REGULATIONS

- Only serious, unsigned rock bands are eligible
- Other eligibility requirements:
 - All individual band members must be at least 18 years of age and up. All band members must have written parental permission to participate who is under 21 years of age.
 - The band must have original playlist sufficient to perform 30 minutes live on stage. (no covers)
 - Promoter will provide the festival backline, 5 airline tickets to/from Germany, and accommodations in Germany for the winning band.
 - Application start: 1st August and the deadline is: 31st October 2008 (12:00 midnight UAE time)
 - On mid November 20 bands will be chosen as the semi finalists to be uploaded to the website and the fans will vote until December 25th 2008 (12:00 midnight UAE Time) on who will win to perform at desert rock and at With Full Force.
 - On Mid January the winning band will be announced.

- The winning band voted the most on the website and all its individual members must be available, ready, able and willing to perform at the time designated for the Festival.
- The band must submit the following on or before October 31st 2008 (12:00 midnight)
 - A Demo video (creativity is a plus)
 - 2 original songs on a CD
 - Photographs of the band and its individual members
 - Bios of the band and its individual members
 - Terms and Conditions signed by all band members (and parents, where required) on the Acknowledgement and Agreement below.
 - Submit your application form and above contents to the following address:
 - CSM Center Stage Management, Office 102 B, Jebel Ali Bldg. Al Quoz, between 2nd and 3rd Interchange of Sheik Zayed Road, Dubai, United Arab Emirates
- The decision of CSM and the judges as to which bands will the semi finalists uploaded to the website will be FINAL.
- CSM shall not be responsible in any manner for transportation, accommodation or any other expenses which may incurred by or on behalf any member of the band or any other person whatsoever, whether in connection with the Desert Rock Festival or otherwise.
- The band must immediately notify CSM of any changes in composition of the band, including its individual band members, prior to the festival and CSM will have the final decision as to whether and to what extent any such change will impact its choice for the band to perform at the festival or at With Full Force.
- The band's performance at the Desert Rock Festival and With Full Force (should it be chosen as the winner), shall be subject to CSM and the Venue obtaining the requisite approval(s) for the band and its individual members to perform at each event from the applicable governmental authorities and Visas being approved.
- Eligible to enter are from United Arab Emirates, Pan Arab, Middle East.

REQUIRED LICENSE: The band and each individual performing in the band or who may otherwise have any right, title or interest in or to any music, lyrics, audio or visual materials submitted to CSM or Desert Rock Festival/With Full Force, must grant CSM certain, non-exclusive rights, without payment to the band, any of its members, other persons or companies, but with due credits for all original works given. Such rights shall include, but not be limited to:

The right to publish, distribute and use on any and all media, pictures, video, sound or any other recordings any and all audio or visual materials submitted by the band as well as any audio or visual images captured live at the Desert Rock Festival and With Full Force (hereinafter collectively referred to as "the Sounds & Images), as well as any compilation created by or on behalf of CSM, "), for purposes of advertising, promoting and/or marketing CSM, Websites 2008 and subsequent years and the Desert Rock Festivals;

The right to use and sell any audio and/or video compilation created by or on behalf of CSM which incorporate any of the Sounds & Images; however, CSM will not sell or license to any third

person the right to use the Sounds & Images or any of the material submitted to CSM without the band's express written consent, given by its designated contact members.

The right to use the Sound & Images in order to promote CSM's product and services and to use the name, likeness and biographical material and any logos, marks or trade names of the band and/or any individuals performing in the band or otherwise represented in the Sounds & Images or the artist or band included or referred to in the Sounds & Images; and

The right to use the name, likeness and biographical material and any logos, trademarks or trade names of the band and /or any individuals performing in the band or otherwise represented in any materials provided CSM by the band or its individual members.

NOTE: The band and/or its individual members shall retain full ownership of all right and title to the original works referenced above, including any related copyrights, trade names and trademarks, subject to the non-exclusive rights granted to CSM. As the license that will be granted will be non-exclusive, the band and/or its individual members will be free to grant similar rights to others at any time, subject to this license.

ACKNOWLEDGEMENT & AGREEMENT

The band and each individual member of the band hereby warrant that they, and each of them, have read, understood and agree to be bound by and conform their conduct to the forgoing rules and regulations and that they have the full rights, power and authority to grant the license referenced herein. They, and each of them, further agree to indemnify and hold CSM harmless with respect to any and all acts, omissions, claims, liabilities, damages, harm, injuries, expenses, or any other losses arising out of or in any manner related to any of the subjects referenced in these Rules & Regulations, regardless of the cause of same and without regard to fault.
